- strategic advice on the most appropriate visa application, and the timing of the same,
- applications to come to the UK as a skilled worker,
- applications to come to UK as the sole representative of an overseas business,
- applications to come to the UK as Tier 1 (Investors),
- applications for family members to accompany the senior executive to the UK,
- applications for key members of the senior executive's domestic staff, in particular nannies, to accompany the senior executive to the UK,
- applications for permanent residency, particularly on an exceptional basis,
- applications for British Citizenship, particularly on an exceptional basis,
